

Alternate School Plans Suggested

Editor's note: With this issue we complete the installments which we have been publishing each week of the school survey made last year by Gilbert P. Pearson of the University of Connecticut. We have received much commendation for placing this report before the people of the town where it would receive wider circulation than that afforded by the annual Town Report Books in which it first appeared. Since the survey was finished a plan has been worked out by the Board of Education by which additional space is made available in the grade schools by transferring all seventh and eighth grade pupils to the high school where there is not only ample accommodation, but facilities for a greatly enlarged and extended curriculum. This new plan, which becomes effective next fall, largely supplants the suggested program of Mr. Pearson.

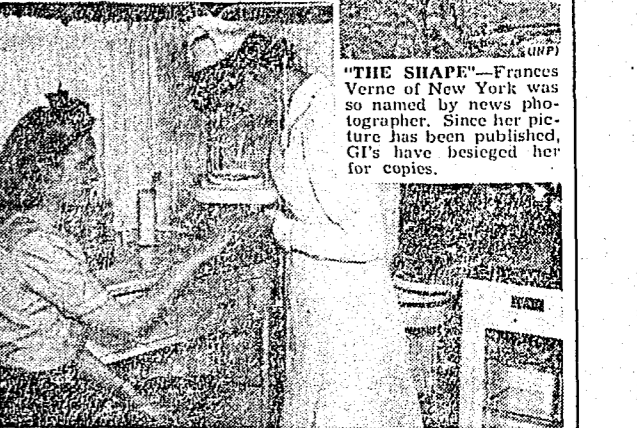

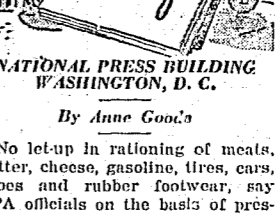
