## Teachers Offer Blood In Preparation For Monday Donor Program

East Haven teachers were among the town agencies being contacted today in preparation for the coming visit of the Red Cross Bloodmobile next Monday. The unit will be set up in the lower Town Hall where arrangements to handle at least 200 persons are being made. The East Haven quota has been set at 150 pints. Mrs. Eric Dohna who is the local Chairman of the Program has already sent out appointment cards and it is hoped that the response will make possible the full quota of blood. Whether receiving an appointment card or not, anyone is welcome to "Just Walk In" and he or she will gladly accept. A trained staff from Hartford accompanies the Unit and is assisted by local trained nurses serving on a voluntary basis. It is an unassuming, unordinary conditions, to check with family physicians as medical histories taken at the Blood Center are carefully checked by the Doctor in charge. Every able-bodied person is urged to respond to the appeal for the blood which is so urgently needed in the Hospital as well as in Korea. The slogan "THE LIFE YOU SAVE MAY BE YOUR OWN" may well apply to this program.

## Dental Clinic In Schools Underway

The first full year of a dental clinic program in East Haven schools got underway Tuesday, according to an announcement by Supt. of Schools William E. Gillis. The program, which consists of examination and cleaning, was started last Spring in the elementary grades. Work this year begins in the center elementary schools, leaving the high school grades until later in the year. Plans for the clinic were discussed at a recent meeting of Mrs. Oren Parker, chairman of the program, Mrs. F. T. Flood, a member of the committee, Mrs. Phelps Lewis, dental hygienist, and Superintendent Gillis. It is expected that an average of two or three days per week during the year will be spent on the examination and cleaning. Investigation is also being made of a plan to include a fluorine treatment in the dental program.

## Blood Donor Program Called "Your Gift Of Life" But Response Is Slow To Needs

"Blood is the magic gift of life," Chairman of the Red Cross Blood Donor program in East Haven, Mrs. Eric Dohna, said today in urging East Haven residents to assist the Bloodmobile program on October 29 from 2 to 7 P.M. in the Town Hall. Public response has been slow and the need has increased since the Bloodmobile made its visit some time ago, she said. Donors are urged to "just walk in" whether they have an appointment or not. The story of blood is a fantastic and fascinating one which, even yet, has only been partially unfolded. Every normal person has about a gallon and a half of whole blood, from twelve to thirteen pints within the body. It is our best wonder medicine, as whole blood, as plasma, as any of the half dozen parts or fractions that scientists can now draw from it. If flows through 60,000 miles of arteries, capillaries and veins to bathe the body, to take it oxygen and carry back carbon dioxide and other wastes. Blood contains everything necessary for life health. It carries hormones, the potential regulators of life; vitamins and enzymes of dozens of vital chemical activities. Fifty five percent is fluid, a yellow colored liquid called plasma and the remaining forty five percent is made up of red cells, white cells and platelets. Plasma is one of the giants for fighting shock, a major cause of

## Four Persons Hurt In Saturday Crash On Saltonstall Pkwy.

Four persons were injured, one of them tied up in traffic on Saltonstall Parkway, East Haven, Sunday night. The accident occurred when a car driven by August Bova, 18, of 110 Derisla Avenue, East Haven, was forced into another vehicle, driven by Elpidio Farina, 21 of 55 Bishop Street New Haven, as Farina was waiting in the center lane to make a turn into the Post Drive in Theale and his passenger Bove told police he had been following another car which was moving slowly, but would not allow him to pass. He said he finally increased his speed and drew alongside the other car, which cut sharply and forced him into Farina's car. A passenger in Bova's car Dante Nordini, 17 of 74 Massachusetts Avenue, East Haven, was admitted to New Haven Hospital with head injuries. Two others in the accident were treated and released. They were John Flagg, 21 of 263 Laurel Street, East Haven, who suffered a lacerated hand and a fractured arm, 21 of Bellevue Road, Westville, who received lacerations to the back of the head and who was suffering from shock. Bova was treated for a lacerated forehead and left hand. The driver and his passenger were thrown into the back seat by the force of the impact. Both cars had to be towed away. Police are looking for the driver of the third vehicle, which was driven by Patrolmen Walter Heck, Frank Konesky and Louis Terello of the East Haven Police arrested both Bova and Farina on motor vehicle charges.
