High School, Miss Keefe is a graduate of the Connecticut College for Women New London and received her master of arts degree from Colum bia University in student person-nel in 1947. She has also one ad

ditional graduate work at Harvard Graduate School of Education The newly elected dean of girls will bring the East Haven schools and community a wide and varied range of experience. She accepted the position of assistant librarian at the Naugatuck Public Library following graduation from the Connecticut College for Women.

She then became a teacher at the Putnam High School, her alma mata. Then she taught at the Norwich Free Academy, Ben Franklin Junior High School, Ridgewood, N. J., and at Mohawk College, Utica, N. Y.

In 1948, Miss Keefe went to Chunchon, Korea in the employ of the War Department Service Club Division. Following the year

Miss Keefe was awarded a Fulbright scholarship in 1952 and gave up her work at Heidelberg to become a teacher of English with a title of "Ambassador of Good Will" to Ban Sondej Normal School, Bangkok, Thailand for the ore year period of the special interna-tionally awarded scholarship. Miss Keefe, is at Columbus University for the summer where she is a cial assistant at the Teachers special a College.
